Producer may edit my Appearance as Producer sees fit, and I understand that Producer has no obligation to use my Appearance. I acknowledge that a still photographer will be present during the dates of performance, and I grant Producer and its affiliates, successors, licensees and assignees the right to copyright and use said photographs without further compensation to me in printed publications or any other media, without restrictions. Producer shall also have the right, and I shall fully cooperate with and allow Producer to produce, distribute and otherwise exploit trailers and "behind-the-scenes" or "making of" programs incorporating my Appearance.

I hereby release and discharge Producer and its affiliates, successors, assignees and licensees from any and all claims, demands, or causes of action that I may have, whether for libel, violation of my right of privacy or publicity, or any other matter arising out of or in any manner connected with the use of my Appearance or the exercise of the rights granted herein. I also agree to not provide similar modeling or acting services (nude or non-nude smoking or posing with weed) for any and all projects and productions including, but not limited to internet, film, video, cell phone content, books, magazines, posters and all other print, digital and motion picture media known and unknown for the period of five years from the initial release of my images and/or video by 420 Magazine, 420 Girls or one of it's wholly owned subsidiaries, assignees or affiliates.
